1. Call To Order

Commission on Aging Chair Dave Smith called the meeting to order at 3:30 pm on October 6, 2021 in room A of the Watertown Community Center.

4.A. Holiday Dinner Discussion

Amy Dimmler stated that Community Education has been receiving many calls for reservations for the Senior Holiday Dinner. event becoming a super spreader. Dawn Plumer with Carver County Public Health suggested limiting the number of people who can attend. The commission discussed possible options and their thoughts on COVID-19 restrictions affecting the Senior Dinner. The commission discussed postponing the dinner to the spring and either having it outside or back at the community center.

4.B. Historical Society Legacy Project Update

Marty Bergland from the Historical Society said the Society had started to interview local residents about their history prior to COVID. The purpose was to start a legacy document that the family would have as a keepsake and continue to share the history of the family. Bergland said the interviews stalled due to COVID. Raymond said she reached out to the Historical Society in hopes that the Commission on Aging could assist with this Legacy Project. Ericsson shared that the library will be applying for a grant that will allow media to be converted from older versions to digital. Ericsson said part of this will be obtaining recording equipment and could possibly tie into the legacy project. Tschudi said the community center rooms could be used for the interviews as well. She said the Commission on Aging could help in any way they see fit.
