Pursuant to due call and notice thereof, the regular meeting of the Watertown City Council was called to order in the Council Chambers of City Hall at 8:31 AM on Thursday, August 4, 2022, by Mayor Steve Washburn.

City Administrator, Jake Foster, described the terms for which staff was recommending the appointment of Kimberly Block to the Administrative Assistant position. The Administrative Assistant position is a Grade 9 on the City's approved salary scale, and it was recommended that Ms. Block start at Step 1 with a bank of three (3) weeks of Paid-time-off (PTO).

Mayor Washburn noted that the City of Watertown sets a very high expectation for staff relating to customer service. He asked Administrator Foster how Ms. Block's customer service skills were vetted.

Foster described the interview process, staff members that were included in the process, and provided some general examples of customer-service-related interview questions that were asked of Ms. Block. There was general discussion related to the position and Ms. Block's qualifications.
