Background:

Anderson Race Management has been hired by Gear West to organize the bike portion of the Liberty Triathlon which will take place on Sunday, August 1 from 7:30 am – 12:30 pm. The last time this event took place in 2018, the route used only county roads. The applicant is requesting to use portions of Paul Avenue, Kristi Lane and Robert Street for the 2021 route.

The event coordinators will need to follow the County's permitting process for use of the County roads within City limits. Anderson Race Management will be solely responsible for providing for additional law enforcement support or services at their cost from the Carver County Sheriff's Office and or other volunteers to provide traffic and directional assistance at their cost.

Staff is recommending use of streets for the sections of Paul Avenue, Kristi Lane and Robert Street for the Liberty Triathlon.

RESOLUTION APPROVING USE OF STREETS

WHEREAS, the City has received a request from Anderson Race Management to use portions Paul Avenue, Kristi Lane, and Robert Street for the Liberty Triathlon bike event on August 1 from 7:30 a.m. to 12:30 p.m.; and

WHEREAS, Anderson Race Management will be solely responsible for providing for additional law enforcement support or services at their cost from the Carver County Sheriff’s Office and or other volunteers to provide traffic and directional assistance at their cost; and

NOW, THEREFORE, BE IT RESOLVED, that the City Council of the City of Watertown, Minnesota, hereby approves the use of said municipal streets under the conditions listed for the Liberty Triathlon.

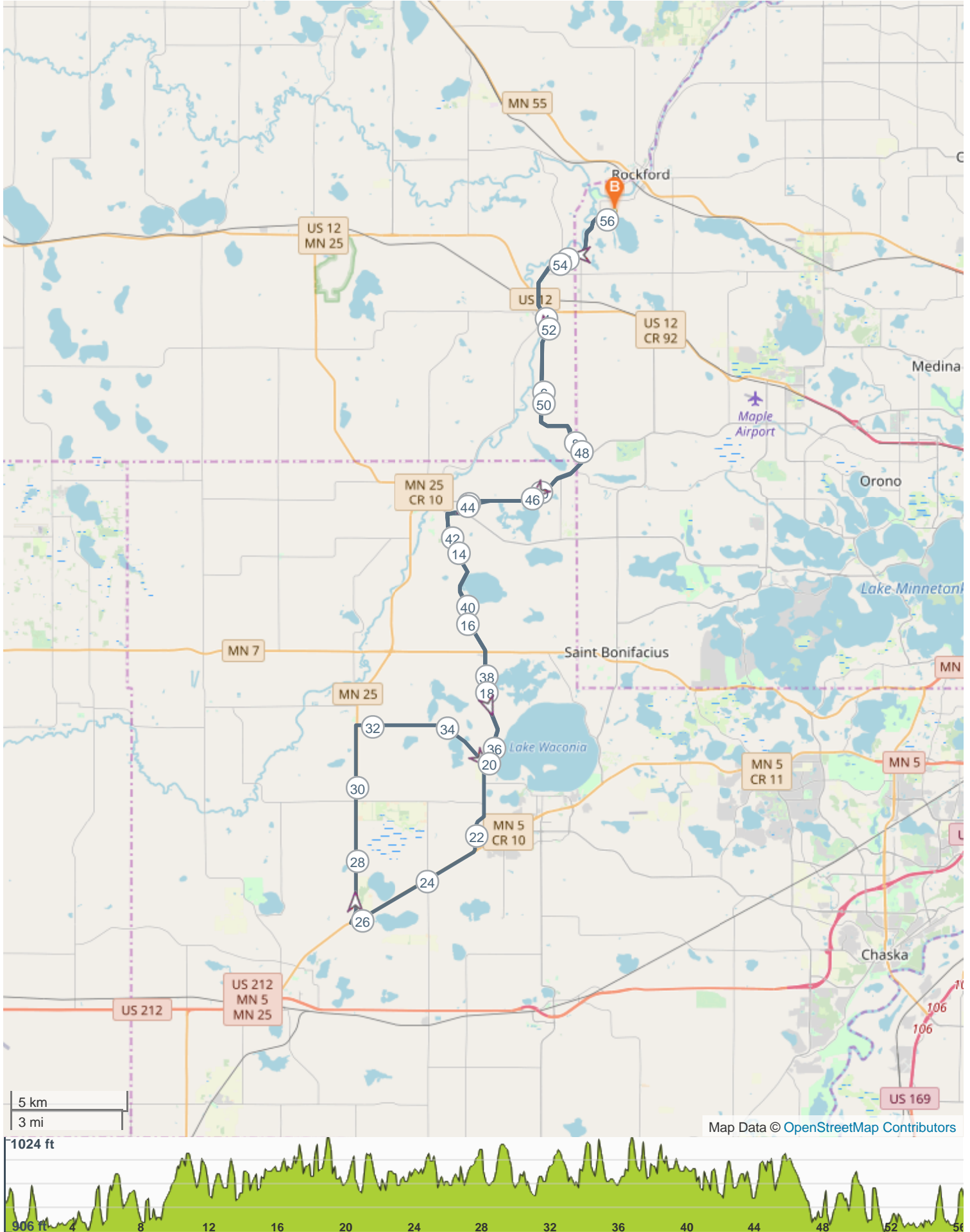
