At present no library locations have 1040 booklets or forms. These typically start arriving in mid-January or later. Reminders:

- The IRS only sends out 1040 forms and booklets. The state of Minnesota sends no tax products.
- Most available individual tax forms and instructions can be printed at the library for \$.15 per black and white page.
- Library staff aren't able to provide tax advice.
