**Background:**

The Watertown Lions Club has applied for four “1 Day – 4 Day Temporary On-Sale Liquor Licenses”. The Lions Club is wishing to serve alcohol at the following four separate events:

Event 1: May 17, 2023, at 309 Lewis Ave, City of Watertown Community Center.

Event 2: June 8, 2023, at 309 Lewis Ave, City Parking Lot at City of Watertown Community Center.

Event 3: July 13, 2023, at 309 Lewis Ave, City Parking Lot at City of Watertown Community Center.

Event 4: August 10, 2023, at 309 Lewis Ave, City Parking Lot at City of Watertown Community Center.

The Lions Club has paid the required \$50 application fee and has provided the required certificate of insurance.

After the City Council approves the applications, the application materials are sent to the State of Minnesota’s Department of Public Safety for approval by the Alcohol Enforcement Division.

**Recommendation:**

Staff recommends adopting Resolution #2023-30 approving the four temporary intoxicating liquor licenses for the Watertown Lions Club.

**RESOLUTION APPROVING FOUR TEMPORARY INTOXICATING LIQUOR

**WHEREAS**, the Watertown Lions Club has applied for four temporary intoxicating liquor licenses for the following four events:

Event 1: May 17, 2023, at 309 Lewis Ave, the City of Watertown Community Center.

Event 2: June 8, 2023, at 309 Lewis Ave, City Parking Lot at City of Watertown Community Center.

Event 3: July 13, 2023, at 309 Lewis Ave, City Parking Lot at City of Watertown Community Center.

Event 4: August 10, 2023, at 309 Lewis Ave, City Parking Lot at City of Watertown Community Center.

**WHEREAS**, the sale of “strong beer” and 3.2 beer under a temporary license is acceptable under City Code Chapter 6.

**WHEREAS**, the Watertown Lions Club has provided liquor liability insurance for the events.

**NOW, THEREFORE, BE IT RESOLVED**, that the City Council of the City of Watertown, Minnesota, hereby approves the applications for temporary intoxicating licenses for four events from the Watertown Lions Club for the requested dates and locations.
